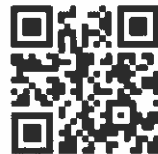

What TO DO if you are in an Auto Accident

1. **Stop** - It is illegal to leave the scene of an accident
2. Call **911** - For Assistance. Cooperate with Police
3. **Exchange** - Information. Write it down in the "Notes" section
4. **Obtain** - Witness Information and write it in the "Notes" section
5. **Take Pictures** - of ALL vehicles involved, injuries, and the scene
6. **Seek** - Medical Attention. Have a physician evaluate your injuries **ASAP**
7. **Notify** - Your own Insurance Company
8. **Call US IMMEDIATELY** - Boesen Law - 303-999-9999. The time immediately after an accident is **vital** to your claim.

Evidence must be gathered, witnesses interviewed, and other case elements must be developed - all within the allotted time for making your claim.

What NOT TO DO if you are in an Auto Accident

1. **DO NOT** - Admit any fault. State only the facts about what happened
2. **DO NOT** - Sign anything (except a ticket or police form)
3. **DO NOT** - Give written statements or talk with the other driver's insurance company without your attorney's involvement
4. **DO NOT** - Complete insurance forms without the advice from your attorney
5. **DO NOT** - give recorded statements to any insurance company without your attorney
6. **DO NOT** - Sign any medical releases for the insurance company without advice from your attorney
